- *An application fee of \$100 must be included with the initial application.*
- *Students may be placed on a Visitor Status before all paperwork is completed. In some cases, a Visitor Status may be warranted for students who start after the school year begins or if there is a history causing concern. After the two weeks, students then will be placed on Probationary Status.*
- *All new Students will be on a probationary status during their first quarter. Probationary Status is not full enrollment which means a student is not guaranteed full enrollment and can be dismissed.*
- *Be sure to distribute Spiritual Leader, Teacher, and Christian Reference Forms and ask the reference person to mail the forms back within a week from the time you turn in your enrollment application. If the initial application is approved, the student will receive the following documents: Family Registration Form (for language survey, pick-up and contact information, and health, insurance and medical information), Financial Information & Contract, and a Fine Arts Selection Form.*
